#### Bible Institute in Pakistan:

In August 2018, a ten-day Bible institute/seminary class was held for 11 men and some of their wives in Pakistan via the Internet. WELS' friendly counselor to Pakistan and his contact, both based in the U.S., taught the class from 10 p.m. to 6 a.m.

each day so it could be held during the daytime in Pakistan. The goal is for the men to visit four to five different house churches every week and teach what they learned. #### **Fellowship established**

**in Kenya:** In September 2018, our sister synod, the Lutheran Church of Central Africa–Zambia Synod (LCCA-ZS) met in convention for the 31st time in its history. The LCCA-ZS was established as a mission by WELS and has since



become an autonomous church body in fellowship with WELS. Delegates at that convention approved the recommendation of the LCCA-ZS Synodical Council to declare full fellowship with Lutheran Congregations in Mission for Christ (LCMC) in Kenya. The next step will be a formal recommendation by the LCCA-ZS to accept the LCMC-Kenya into the fellowship of the Confessional Evangelical Lutheran Conference, of which WELS is a member. WELS anticipates declaring formal fellowship with the LCMC-Kenya at its 2019 convention. Learn more about mission work in Africa at **wels.net/africa.** 

#### Ukrainian Lutheran Church celebrates 25

Years: 2018 marks the 25th anniversary of the renewal of the Ukrainian Lutheran Church (ULC), a valuable mission partner in Eastern Europe. The pure gospel voice of the Lutheran church has been silenced in Ukraine for almost 50 years and two generations of people. In 1993, two public Lutheran worship services

Connecting stateside Spanish speakers with their home countries: Academia Cristo exists to help Spanish speakers share Jesus and plant churches in Latin America. The Latin America missions team recently established two new bases of operation to assist in that effort. Missionaries Nathan Schulte and Philip Strackbein have relocated to Quito, Ecuador, and Latin America Missions Field Coordinator Mike Hartman and his family have moved to Miami, Fla. By moving stateside, Hartman hopes to interact with stateside WELS members from Latin America

**Multi-Language Publications:** Multi-Language Publications has produced print items, audio

and video resources, and online training resources in more than 52 languages. These resources have reached 11.9 million people with the gospel message, with over 67,000 people actively studying the Word using MLP materials. In 2018, MLP held a translation seminar in



Lusaka, Zambia, with representatives from over eight countries in attendance. In 2019, MLP will be hosting a media seminar to continue their collaboration with world mission fields as they identify their media needs and determine the best way to fill those needs. opportunity in communist Vietnam. The Vietnamese government has invited WELS to build a theological training facility in the capital city of Hanoi to train leaders of the Hmong Fellowship Church (HFC) in Lutheran doctrine and practice. To take full advantage of

this incredible mission opportunity, WELS is collecting a special offering called "Grace--Hmong outreach in Vietnam" through June 30, 2019, with the goal of raising \$2 million to fund the land purchase, building construction, and the first two years of operational costs for the theological training facility. ## Home Missions Updates – Spring 2019

#### 2019 Home Mission New Starts and Enhancements

Every spring, the Board for Home Missions (BHM) and the BHM Executive Committee prioritize requests for new missions and ministry enhancements. In 2019, 16 requests were received. Due to declining Congregational Mission Offerings (CMO), fewer designated gifts to Home Missions, and higher than expected funding requests from current home mission churches, the BHM was only able to approve financial support for one new start and one ministry enhancement. Two other new starts were approved with financial support coming from other avenues for the coming two fiscal years. Finally, an existing mission is receiving financial support outside Home Missions and has become an unsubsidized mission.

#### 2019 Home Missions New Starts:

 <u>Houston, Tex</u>. – A dedicated group of core members (pictured) from other WELS churches around Houston are starting their new mission "inside the loop" of Interstate 610. This urban neighborhood is seeing a resurgence in popularity as people are looking to be closer to the city center.

#### 2019 Home Missions - Unsubsidized:

 <u>Folsom, Calif.</u> – St. Mark's, Citrus Heights, is daughtering a new congregation called The Rock Lutheran Church in Folsom, a growing community in the greater Sacramento area. A



generous WELS donor has come forward to help support this new mission.

- <u>Wesley Chapel, Fla.</u> A nearby WELS church is closing, but members are committed to starting a new home mission in this promising community, using the funds made available from the sale of the other church property.
- <u>Killeen, Tex.</u> A strong core group of members are ready to restart their congregation, with a focus on reaching out to the community and to the military base in their area. Funds from the sale of a WELS congregation in Texas are helping support this mission effort.

#### 2019 Home Missions Enhancement:

Martin Luther Lutheran Church, Oshkosh, Wis. – For over 35 years, Martin Luther, WELS Campus Ministry, and other local WELS congregations have supported a campus ministry at the Rising Son Ministry Center on the University of Wisconsin-Oshkosh campus. In partnership with Martin Luther financial support, reserve funds have been allocated by the Campus Ministry Committee to help support a third pastor at Martin Luther. The pastor will serve half-time at Martin Luther and half-time at Rising Son Campus Ministry.

### WELS Christian Aid and Relief Summer 2019 update

WELS Christian Aid and Relief serves as our synod's "ministry of compassion," bringing physical relief to victims of natural disasters in the form of cash grants, food, clothing, and medical supplies. Christian Aid and

Relief also partners with WELS missionaries to support humanitarian aid projects to help build bridges to proclaim the gospel. The mission of Christian Aid and Relief is drawn from the Scriptural encouragement, "Therefore, as we have opportunity, let us do good to all people, especially to those who belong to the family of believers." Galatians 6:10 Because of all that Christ has done for us, we are eager to reflect Christ's love and compassion to those in need. We seek to personalize our efforts by conducting careful assessments and distributing our funds through our churches and missions. We bring in volunteers when requested to assist in the recovery effort.



# **Our Current Situation**

Christian Aid and Relief is funded by the special gifts of WELS members. Thank you for your gifts of love!

From July 1, 2017 through June 30, 2018 our total expenditures for relief projects were \$633,056 with \$461,291 designated for domestic relief efforts and and \$171,765 for foreign relief efforts. From July 1, 2018 to February 2019 our relief expenditures were \$501,872 total with \$278,332 designated for domestic and \$223,540 for foreign. In addition, \$357,403 was designated for Humanitarian Aid projects for fiscal year 2018-2019 which assist our missionaries in building bridges to proclaim the Gospel.



# **Our Current Situation** continued

### **Humanitarian Aid Projects**

At their June 2018 meeting, WELS Christian Aid and Relief approved \$357,403 for humanitarian aid grants for FY 18-19. These projects help our missionaries reflect Christ's love to people in need, and also open doors to share the Gospel. Major items include health clinics, borehole drilling to provide clean water, support for a women's skill center, home based care for the chronically ill and dying, food assistance to the needy adult literacy classes, food and nutrition to orphans, medical equipment, and health clinics. Grants have increased recently to more home mission congregations especially welcoming new legal immigrants in cross cultural situations.

Home Missions receiving grants this year are: Las Vegas, NV, Toronto, Canada, Texas, Denver, CO.

World mission fields receiving grants this year are: Africa – Zambia, Malawi, Nigeria & Central African Medical Mission Asia Pacific Rim – Thailand and Indonesia, Europe – Russia, Albania, Bulgaria, Ukraine South Asia – Nepal, Pakistan, and India Latin America – Mexico, Haiti Apache Mission - AZ



Criteria for humanitarian aid project – A world or home mission project that meets a community need and opens doors to share the Gospel as part of the mission's outreach to their community.



### **Medical and Financial Emergencies**

Our committee also assists local congregations as they reach out to display Christian love and compassion to their members facing natural disaster medical emergencies and financial crisis. #### **Disaster Relief** Hurricane & Diaster Relief Update:

We work through our pastors and synod and congregational leaders to make assessments and distribute aid. We bring in volunteers when requested to assist in the recovery effort. ### **Disaster Relief**

#### **Puerto Rico**

Major opportunities to provide relief in the past year centered in Puerto Rico where more than \$300,000 was granted to assist the Confessional Evangelical Lutheran Church of Puerto Rico. Funds and volunteers were provided to rebuild two churches and two parsonages, repair member homes, and offer ministry encouragment and worker training through Rev. Larry Schlomer Sr: Initially, groceries were distributed to families in need and \$5,000 was granted to provide meals for people in the church and community suffering from this disaster. This enabled members of the national church to provide meals for 50 people a day for four weeks. The new church in Humacao was dedicated Febuary 10, 2019.



#### Texas

Volunteers from neighboring churches helped with initial flood cleanup efforts in several affected areas. Equipment from our relief trailers was put to good use. We were blessed with wonderful volunteers and project coordinators. They repaired a parsonage and church at Christ our Savior, Angleton, Texas: the school at Sienna Plantation Academy; and about 17 member homes in the Friendswood, Texas, area. Volunteers often express what a joy it is to serve Christ by assisting people in their time of need. Special thanks to Builders for Christ volunteers for their excellent reconstruction work. Builders for Christ is a ministry of Kingdom Workers.

### **Disaster Relief** continued

#### Florida

Volunteers, with the help of our relief trailers, assisted with the cleanup efforts in several communities affected by hurricanes, most recently Panama City, Florida. Generators and equipment, rental assistance to those displaced from their homes, and financial grants to assist with the cost of repairs and replacement of furnishings were provided. More than 300 volunteers have repaired the Amazing Grace, church and parsonage in Panama City, along with homes in the community. Over forty student volunteers from Martin Luther College also played an active role in the recovery effort.



#### Antigua, Barbuda and Dominica

Assistance was provided to families displaced from Barbuda, who are staying with members and friends of our WELS mission, St. John, Antigua. Twenty-nine families received \$18,000 in immediate aid so far. Funds were also distributed to assist families in Dominica affected by the hurricane. Assessment of opportunities to rebuild 13 homes in Dominica for families connected to our churches in Antigua and St. Lucia is ongoing.

#### Mazomanie

Homes in Mazomanie suffered flood damage during the month of August, 2018. Volunteers from St. Andrew, Middleton, Wisconsin and around the state offered their assistance to help those in need with the cleanup effort. Community outreach and assistance, under the direction of Pastor Kelly Huet, continued long after the flood waters receded. Thanksgiving Day meals were delivered and Christian Family Solutions came and made a trauma - crisis presentation to those who suffered loss.



#### Brownsville

On September 1, 2018, WELS Christian Aid and Relief helped coordinate a relief effort with St.Paul, Brownsville, WI to offer aid to St. Paul's neighbors who suffered damage from several tornadoes that swept through the area. More than 85 WELS members from sister congregations as well as community members joined together to help those in need. Two relief trailers were mobilized to bring in chainsaws, rakes and other tools needed.





# **A Look Ahead**

Annually, Christian Aid and Relief reviews humanitarian aid grant requests forwarded to us from the Board for World Missions and Board for Home Missions. These projects help build bridges for proclaiming the Gospel to the people we serve in our mission fields.

WELS Christian Aid and Relief continues to look for ways to improve its communication to the members of our synod. "Lifeline" videos have been developed so that those who support our work can see firsthand how their gifts are being used. Our Web page www.welsnet/relief continues to offer timely information and a convenient way to donate online for Christian Aid and Relief projects. Members can also find us on Facebook at Christian Aid and Relief. Committee members and volunteers also make presentations to various groups to "tell our stories", letting WELS members know about the needs and opportunities to help people through Christian Aid and Relief. DVD's of Lifeline Videos and other written materials and photos are also available upon request. We are partnering with other WELS agencies, such as Kingdom Workers, Wisconsin Lutheran Child and Family Service, and the nurses association to coordinate volunteers to assist in relief efforts when appropriate.

### Humanitarian Aid Projects June 2018 – 2019

Christian Aid and Relief continues to partner with the WELS Board for World Missions, Board for Home Missions, WELS Missionaries, and our sister congregations of the Confessional Evangelical Lutheran Conference around the world in funding humanitarian aid projects which reflect Christ's love through acts of kindness to people in need and builds bridges to proclaim the good news of God's love through Jesus. Below is a list of humanitarian aid projects for FY 2018-19 totaling \$357,403. We praise God for all those who helped to fund these projects through their special gifts!

#### Albania

Christian Aid and Relief provides funding for Christmas and Easter food baskets for needy individuals in their congregation and in their neighborhoods. Invitations and information about the congregation are shared with the recipients of the baskets.

#### Bulgaria

Funding has been granted to provide packages with food products, along with Christian books and brochures, for visitors to major festival worship services. With the Lord's blessing this will help build bridges to share the gospel with more people and to maintain connections for ongoing ministry contact.



#### **CAMM – Central African Medical Missions**

The Central African Medical Missions in Malawi and Zambia receive funding from Christian Aid and Relief for medical supplies and nutritional supplements for infants. CAMM currently provides medical care at four clinics which also serve as LCCA churches. These humanitarian efforts help serve as a bridge for proclaiming the gospel.

#### India

Medical aid to India has been approved to provide supplies for government and private hospitals and health clinics. This includes basic necessities such as blood pressure cuffs and thermometers, hospital beds, baby warmers, and more sophisticated equipment such as an instrument to test for glaucoma. Funds have also been granted for the digging of approximately 20 fresh water wells. As with most of the humanitarian work in India, these projects may not open new doors directly for gospel "bridge building," but they will help to ensure that the doors to India will remain open for WELS counselors living and working there. These kinds of projects are necessary for our presence in India to continue; it is excellent and necessary PR with the local medical community, government officials, and other influential people.

### Humanitarian Aid Projects June 2018 – 2019 continued

#### Indonesia

Funding has been granted to assist congregations in Indonesia to hand out staple food items to needy households in their neighborhoods. In some cases, books and school supplies will be given to needy children. The hope and prayer is that caring and sharing will provide a bridge with these people by letting them know the location of the source of the aid and by strengthening the churches' reputation and communication among their neighbors.

#### Malawi

Funding by WELS Christian Aid and Relief for boreholes dug in Mayaka and Nagome are now functional for the people in these villages for drinking, cooking and cleaning. These two wells open the door for the gospel message to be shared by allowing permanent churches to be built. A vicar will be called with the well nearby to supply water for his family. Vacation Bible school and other programs can now be held knowing that there will be water for the children to drink. Water is such a basic human need and without it there is no life. What a blessing to be able to provide water and at the same time provide the living gospel message for the people of Malawi to drink so they may enjoy eternal life!



#### Mexico

Funding for the Costa Maya Ministries Education Center allows the mission in Mahahual to provide a place where the locals can come to hear the Word of God, receive a weekly meal and participate in Bible studies and other outreach opportunities.

#### Nigeria

Funds have been granted to Nigeria to help in the distribution of health care for people in great need, many of which are not members of the local church. The ability to offer care and provide humanitarian aid to Nigeria's unchurched will serve as a bridge for Christ the King and All Saints Lutheran Churches of Nigeria to invite villagers to church to hear the gospel. Funds will also be used to help offer pharmacy services and health education in rural areas demonstrating the loving care of Lutheran Christians. Aid will provide support for church members to visit rehab centers, hospitals, prisons, orphanages and health centers and to assist widows, widowers, and people with special needs.

### Humanitarian Aid Projects June 2018 – 2019 continued

#### Nepal

Aid supplied to Nepal provides funding for health clinics. At each clinic, workers minister to the physical and spiritual needs of those who receive care. Christian literature is distributed. Clinic often lead to the formation of a Bible study group, and eventually have developed into local churches. Aid is provided to reach out to women in rural and remote areas to offer activities and sessions to improve basic skills. Offering these skills provides opportunities to share the gospel. Aid also provides textbooks for higher secondary level students in several districts in the Himalayan area near the Tibetan border. This opens doors for sharing the gospel in these areas and helps to train future leaders and teachers of the Christian church. Funds have also been granted to provide mosquito nets for victims of local flooding. These nets will protect people from mosquito-borne illnesses and even from snake bites. Providing these nets will provide opportunities to share the love and the hope they have through Christ.

#### Pakistan

In Pakistan, funding has been granted to provide medical care for many families and assist with crippling debt. The kindness shown to those in desperate need opens doors to share the good news of the Great Physician of both body and soul. Funding has also been granted to train women in basic skills like knitting, stitching, and embroidery. Each session begins and ends with a gospel devotion. By learning these skills, women can then support themselves and be spared ill treatment in the public market place and work safely from home to receive income to support their families as well as mission work in Pakistan. Funding has been provided to help toward the cost of medical procedures needed by many families without the means to pay. This kindness shown to folks in desperate life and death situations provides opportunities to share the best news of a Savior. Aid has also been granted for food distribution at Christmas and Easter in neighborhoods bordering Christian homes and schools.

#### Russia

Funding has been granted to Russia to provide food, clothing, hygiene items, school supplies, and medicine for the needy. These gifts will allow for the Law-Gospel pamphlets to be distributed and to invite people to Bible instruction classes. This will let the workers' light shine in the area and grow their reputation of helping those in need. Aid has also been granted to assist institutions such as hospitals, rehab centers, orphanages, and half-way houses. The government values this work and presence, which is very important as it opens the doors for Bible classes and Christian counseling. Through this ministry, Christian literature is left in public schools, rehab centers, and other institutions. These efforts provide additional connections to the local congregations as they reach out to the villages.

#### Thailand

We continue to support the efforts of medically trained volunteers who travel to Thailand to set up week long medical clinics in our village churches. As these clinics draw people from both local and neighboring villages, they provide the missionaries and other workers with a unique bridge for presenting the gospel and for creating good-will presence for our churches through such care and service. Eye glasses and hearing amplifiers are two of the many gifts that are shared with the people. These gifts not only open their eyes and ears to the world around them, but open their hearts to a clearer understanding of the love that Jesus has for them through the witnessing of the unconditional love of those providing for their needs. VBS and ELS classes are offered and follow up contacts are made after the classes conclude.

### Humanitarian Aid Projects June 2018 – 2019 continued

#### Ukraine

Funding has been granted to provide food assistance for war refugees and help for orphans. This assistance serves as a good Christian witness to many people and shows the love of God to many in great need. It also provides for the opportunity to share the love of God to those who join in worship.

#### Zambia

Christian Aid and Relief provides funding for home-based care that bridges the physical and spiritual care of the chronically ill and dying. This grant will help prepare the Christians in this ministry to better meet the needs of the community through acts of sharing God's gracious gift of salvation as they help those with AIDS, TB, Malaria, and other chronic and terminal illnesses. Funds have also been granted to support a literacy program. A person who is able to read and write is well positioned to do God's work more efficiently, especially where evangelism is concerned. The Central African Medical Mission in Zambia receives funding for medical supplies and medicines that help support the mission of communicating Christ's love and sharing caring concern for the physical needs of others. Another project will help touch the lives of people with special needs by providing wheelchairs, showing them the passion, love and mercy that Christ has for all people. This work of compassion is performed so the gospel may reach those in need.

#### Las Vegas, Nevada

In the Las Vegas, NV, area funding has been granted to assist in African refugee/immigrant Outreach. As new African immigrants arrive in this area, congregation members can welcome them, provide a welcome gift (cooking pots, dinnerware, toiletries, soap...), assist them in getting settled into the community, help with English needs, provide rides, and further assist with counseling, ESL training, etc. The intent of this ministry is to assist the refugee immigrants as they transition to life in America, using this opportunity to proclaim to them the gospel of Jesus through personal witness, worship services and Bible classes.

#### Texas

Congregations in several Texas communities have created outreach events that assist underprivileged families of school age children with much needed school supplies. In conjunction with backpacks and the supplies that are given to the children, Bible stories and videos are shared. Food for all is always part of the days' event, along with games and prizes for the kids. Parents receive information about the church and the programs that are offered throughout the year. Through this effort the congregations seek to encourage families to become a part of their church family and join in Christian fellowship and worship on a regular basis.

#### Toronto

Funds have been granted to Hope Lutheran Church in Toronto, Ontario, as they coordinate a Welcome Project. This project enables the congregation to provide valuable humanitarian assistance to newcomers to their area. The assistance can take the form of food, rental help, and guidance with other matters pertaining to their transition into the area. This project helps Hope Lutheran show Christ's love to new refugees.

#### MISSION AND MINISTRY HELD

From February 5–7, students at Wisconsin Lutheran Seminary participated in Mission & Ministry, an annual three–day event organized by the students. #### PASTORAL STUDIES INSTITUTE UPDATE

**JOSHUA BAION:** My name is Joshua Henry Baion, servant of the Lord, Pastor of Community Deliverance Church. I was born in Tanahun, Kailahun district of Sierra Leone, West Africa. I moved to the States in 1991 and was called into ministry in 1994. I attended the Evangelical Training Seminary and was ordained in June of 2008.

My mother came from a Methodist and Pentecostal background. She taught me the Word of God. She passed away almost two years ago. Shortly after, my sisters decided they were older and would lead the church even though I had been called upon to lead.

This brought confusion in the church that led to a split. With no place to worship, my wife and two other members went with me to the Eagan Civic Arena, where we were secured one of their halls for weekly worship.

After several months, we sought a more suitable place for worship. In the winter of 2017, we were driving down the road, and saw the sign for Crown of Life. We went into the building to speak with the pastor. Pastor Pudlo was very gracious. We explained our mission and our desire to possibly worship in their facility. He rightly told me that sharing the facility was not a matter of money, but about having a shared belief about our Savior.

We went through a Bible Information Course to make sure our beliefs were in line with Crown of Life. After finishing the course, we were welcomed by him, the elders, and the congregation with open arms. We also began the PSI courses. We have covered the courses on Interpretation, the Gospels, and are now working through Luther's Catechism. It has been a great blessing.

**REV. ZACHARY PUDLO:** Josh came to us in 2017 looking for a place for his church to worship. From the moment we met, our goal was



to make sure we agree on God's Word. I think we both have appreciated our time together in the Word of God and growing closer to the Lord and together as fellow servants in his kingdom.

I try to manage my hopes for our partnership with Pastor Baion and Community Deliverance Church. I know he has a better opportunity to reach the growing multiethnic community in Eagan. Maybe the Lord will bless our efforts to share Christ in our immediate community. Or maybe the Lord will bless our efforts as we explore opportunities to bring the gospel back to Sierra Leone. My hopes are to be prepared to go wherever the Lord will lead us.

Being a PSI mentor has been a blessing. The preparation needed to teach courses has given me the opportunity to review the information from my formal time in school. It has been a blessing for my congregation to see Pastor Baion and his members and to get to know their story. The elders and church council have a vested interest in Community Deliverance Church and want to know how they can help this partnership progress. Admittedly, being committed to the PSI program takes time and energy, but it's all worth it. I would never have imagined this going as smoothly as it has, but the Lord has paved a way for us. I can't wait to see how he will bless his kingdom through it.

#### 21st Century Lutheran Principal Program

MLC is working jointly with the Commission on Lutheran Schools (CLS) to fully prepare experienced teachers to be Lutheran school principals. Cohorts of vetted candidates participate in 3 years of training, which includes a 50% tuition scholarship to complete an MS-Educational Administration through MLC.

Two cohorts are being trained, with the first cohort eligible for calls next year. Cohort member Justin Krause states, "Through this highquality, professional cohort, I have gained the confidence needed to one day, God-willing, be the leader of a school."

A third cohort is being organized right now. Please refer recommendations to Jim Rademan at the CLS.

The new paradigm to principal recruitment and preparation involves the following:

- 1. Identify an experienced teacher with gifts for leadership.
- 2. Fully train the teacher according to the WELS Principal Standards.
- 3. Once completed, call that teacher to a school that provides at least the minimum levels of time and compensation.

#### HEB9002 HEBREW REVIEW JULY 8-12, 2019

The Summer Hebrew Review is designed for busy parish pastors who desire to regain and enhance their skills for working in the original language of the Old Testament. It will also benefit students in the WELS worker training system whose studies have been interrupted and who now intend to continue their theological training.

This refresher course will include 14 brief lectures that will begin with Hebrew alphabet itself and the rules for oral reading of Hebrew, and will eventually include every element of basic Hebrew grammar and syntax, with special emphasis on the Hebrew verb. Along the way, students will translate excerpts from the Bible that are rich in Christological and pastoral significance. They will be equipped to explore the sacred text with increasing detail and depth as the week progresses.

#### HEB9001 HEBREW INSTITUTE JULY 15-19, 2019

The Summer Hebrew Institute is an upper-level course in biblical Hebrew for pastors with a strong interest and ability in Hebrew.

The heart of the course will be the rapid reading of 1 Samuel 17-31 in Hebrew—about 30 pages. In these chapters, we will enjoy the lengthy account of David's victory over Goliath and the recurring demonstrations of David's friendship with Jonathan. We will also contemplate the decline and death of Saul, including his visit to the medium at Endor.

We will see Hebrew with a higher-than-average number of textual difficulties and variant readings. In addition, each participant will be introduced to an upper-level Hebrew research tool or teaching tool with which he was not previously acquainted.

For your convenience, the Hebrew courses are scheduled so you can take one or both.



#### GER9001 GERMAN INSTITUTE JULY 15-19, 2019

The Summer German Institute is an upper-level course in theological German for pastors with a strong interest and ability in German. Students will improve their ability to read theological German for content, increase their theological German vocabulary, locate online digitized texts by confessional Lutheran theologians, and read older German by utilizing online dictionaries.

We will read from some of the writings of J.P. Koehler, a unique WELS theologian. In addition to excerpts from his seminal essay, *Gesetzlich Wesen unter uns*, we will read parts of his essay *die Heiligung geschieht nicht mit Hurra*, which has much to say about biblical leadership. As time allows, other possible readings include *das lutherische Lied*, in which Koehler shares some thoughts on music appropriate for Lutheran worship, *Materialismus und Christentum*, in which Koehler shares his view of church history, as well as a couple of his opening addresses to students as president of the seminary such as *das zusammenhängende Studium der Heiligen Schrift* and *Theologisches Sprachstudium*.

### A MESSAGE FROM THE PRESIDENT



What does ministry look like? You probably think of pastors preaching and teachers teaching. You think of bedside devotions and evangelism calls, lesson plans and correcting. If you were to observe our faculty and students this summer, what you would see would not typically rise to the top of your list of ministry sights. But I would propose to you that the summer ministry opportunities are a vital part of the education ministry that we do here at MLS.

Over the two summer months of June and July, over 25% of our student body and 33% of our faculty will be in congregations across North America participating in a program called Project Titus. Project Titus provides our students age-appropriate ministry experiences in mission-minded congregations to give them hands-on experience in ministry. Many have identified this program as one of the most important factors that aided in their decision to become a pastor, teacher or staff minister.

Seven groups of teens and chaperones will visit congregations in a variety of settings to assist with youth and outreach ministries in their communities. This year the communities include Living Savior, Asheville, NC; Saving Grace, Mobile, AL; Messiah, Johns Creek, GA; Palabra de Vida, Detroit, MI; Hope, Ontario, Canada; Camp Shiloh, TX; and Camp Chi-Rho, MD. Vital ministry happens during these trips as our students canvass neighborhoods and assist in a variety of camps including soccer camps, science camps, fine arts camps, and summer camps. One camp will even encourage students to utilize their classroom Spanish skills in a multicultural outreach setting. They will be worked hard, but they will be shining examples as they hone the skills needed to be the future leaders in our churches and schools.

Not every one of those students will return from a Project Titus trip convinced that they will be a pastor or teacher, but each one will have had an experience that will benefit them in their future congregations. Please pray for their safe travels and that they may treasure this ministry experience as they seek to serve their Savior in their lives.

### Dear Partners in Ministry,

The WELS Benefit Plans exist to support WELS ministry efforts by providing quality benefits to workers and their families at contribution rates that are stable over time and as low as reasonably possible. This allows workers to focus on ministry and helps calling bodies to preserve vital assets for their ministry efforts.

Although 2018 was a relatively volatile period for financial markets and the U.S. health insurance industry, we are pleased to report that 2018 yielded another year of stability for participants of the Benefit Plans.

- The **VEBA Plan** rates increased by 6% and 2% for 2018 and 2019, respectively, which are below the national average in each year for employer-sponsored group health plans. The Lord blessed the Plan with lower than expected medical claims costs in 2018, which helped to offset the financial markets that turned sharply down during the last three months of the year. The Plan has maintained stable membership over the past five years, with the number of calling bodies participating in the Plan greater than **80%**.
- The **Pension Plan** pays more than **\$14 million** in benefits to 2,450 retired workers and surviving spouses each year. Plan benefits earned by participants do not vary with short-term results in financial markets. Although the financial markets turned sharply down during the last three months of 2018, the contributions paid to the Plan by calling bodies have kept the Plan in a solid financial position to meet current benefit obligations.



 The Shepherd Plan continues to grow in both participation and assets. More than 2,300 participants have invested \$124 million of their retirement savings in the Plan. This strong growth has resulted in a cumulative decrease of 15.7% in administration fees during 2017-18.

In 2018, Benefit Plans launched a new website with content dedicated to supporting calling bodies in their administration of the Benefit Plans at a local level. The website is available at: **resources.welsbpo.net**. We invite you to visit this site regularly as timely content will be highlighted throughout the year.

As fiduciaries of the Benefit Plans, the WELS VEBA and Retirement Program Commissions along with Benefit Plans staff understand the importance of being good stewards of the assets entrusted in our care. Plan operations are designed for efficiency, maximizing the assets available for benefits and keeping contribution rates low. In 2018, 93 cents of every WELS VEBA contribution dollar were used to pay for current member benefits or to invest for future member benefits, and 98 cents of every WELS Pension Plan contribution dollar were used to pay for benefits for current retirees or to invest for the benefit of future retirees.

The Benefit Plans are portable across all WELS sponsoring organizations in the U.S., allowing workers to continue their benefits wherever the Lord calls them to serve. It is comforting to know that our synod walks together not only in ministry but also by taking care of our workers' health and financial wellbeing through the WELS Benefit Plans.

It is truly a blessing that our synod sponsors Benefit Plans that are comprehensive for workers, cost-effective for organizations, and consistent with God's Word.

We thank you for your continued confidence in the WELS Benefit Plans.

### **AN OVERVIEW**

The WELS Benefit Plans Office serves WELS and ELS workers, their family members and their calling/hiring bodies through the administration of the WELS VEBA Group Health Care Plan (WELS VEBA), the WELS Pension Plan and the WELS Shepherd Plan. Collectively, these plans are known as the "**WELS Benefit Plans**".

The WELS Benefit Plans were formed by WELS to ensure that workers and their families have access to quality health and retirement benefits regardless of where the Lord calls them to serve. By grouping together covered workers under the WELS Benefit Plans, cost efficiencies are obtained and sponsoring organizations don't have to worry about maintaining their own health and retirement benefit plans at a local level.

The WELS VEBA Commission oversees WELS VEBA, and the WELS Retirement Program Commission oversees the WELS Pension Plan and WELS Shepherd Plan. Each Commission is comprised of six members: one pastor and one teacher from the active worker roster, and four lay members in good standing at a WELS congregation. Commission members are appointed to three-year terms by the Synodical Council.

The WELS Benefit Plans Office manages the administration of the Benefit Plans on behalf of the Commissions and provides customer service to participants and sponsoring organizations. A list of Commission members and Benefit Plans Office staff is provided on page 18.

The **Pension Plan** covers approximately 4,300 active workers, pays benefits to approximately 2,450 retirees, and is due to pay benefits in the future to approximately 1,300 vested retirees.

# A smooth process

Pastor Eric Roecker graduated from Wisconsin Lutheran Seminary in 1998 and received his first assignment to Resurrection, Chesapeake, Va. From Virginia, he took a call to Pilgrim, Menomonee Falls, Wis. And, last summer he started serving in a new call as the director of the WELS Commission on Evangelism. He and his family have been enrolled in the WELS VEBA health plan (WELS VEBA) for his entire ministry.

Roecker says having WELS VEBA throughout every call in his ministry has been beneficial to his family. "It's a blessing that you don't have to reapply or get a new insurance plan because you're already in WELS VEBA, and if the congregation uses WELS VEBA, it's a very simple, smooth process."

A year and half ago, his daughter had a serious medical issue. "It was just spectacular the way WELS VEBA took care of everything. We never had to question anything; we never had to argue anything. It was just taken care of. It was a very smooth process. I was really impressed with that. In a time when you have all of this other stuff on your mind to not have to think about the health coverage is wonderful." His daughter was able to overcome her ailment, for a happy ending.

Roecker says the way WELS VEBA is universal throughout participating WELS calling bodies does take that factor out of the mix when called workers are making decisions about calls. When congregations and schools offer WELS VEBA, a called worker doesn't need to consider insurance and medical care for their families when contemplating the next chapter in their gospel ministry.

# Quick responses and helpful assistance

Mr. Greg Milbrath can't say enough good things about the quick responses and helpful staff of WELS Benefit Plans.

He says, "Going into a voters meeting, there's very often that discussion of if we should be changing to lower cost health insurance. Sometimes I contact the [WELS Benefit Plans] office before the voters meeting and we get advice. They've always been very gracious and quick to respond."

It's that service and consistency from WELS Benefit Plans that has kept Salem Lutheran School, Owosso, Mich., using the WELS VEBA health plan (WELS VEBA) since it was offered by the synod. Milbrath has been teaching third and fourth grades and band there since 1978 and it's where he has served his entire 41 years in the ministry.

Milbrath says, "The coverage is good. It's covered the things we needed well. But what makes it so user-friendly is the assistance and help you can get."

He's noticed, as Salem has extended calls to teachers over the years, that the consistency of WELS VEBA throughout the synod, and Salem offering it, removes that component when considering ministry changes. "When you take a call to a place that has WELS VEBA, that's the only question you have to ask. If you receive a call, you ask if the health coverage is WELS VEBA, and they say 'yes,' ... that takes some consideration out of the call. It's one thing you don't have to think about or consider when you're evaluating the call," he says.

### **WELS PENSION PLAN** Financial security for tomorrow

# The **WELS Pension Plan** is a defined benefit plan that provides vested called workers and their surviving spouses with monthly retirement income for life.

Under the WELS Pension Plan, benefits are calculated based on a formula that includes years of credited service that each individual participant has earned, and a benefit basis that is standard across all participants and serves as an average salary approximation based on years of service. The cost of the WELS Pension Plan is paid entirely by sponsoring organizations on behalf of their called workers.

### Value of the WELS Pension Plan to WELS Ministry

The WELS Pension Plan exists to provide retirement benefits for called workers in a way that doesn't adversely impact the call process. Because all WELS called workers participate in the Pension Plan, each sponsoring organization doesn't have to worry about administering its own retirement benefit program. In addition, because Pension Plan benefits aren't based on a worker's actual compensation or responsibilities, a worker's Pension Plan benefits aren't affected by taking a call that provides higher or lower compensation – the ministry efforts of all called workers are valued equally by the Pension Plan.

### Advantages of the WELS Pension Plan

- The Pension Plan assumes the investment risk for contributions held in the Plan's trust on behalf of all workers. Investments are managed by professional consultants, so each worker is protected from making bad personal investment decisions.
- $\checkmark$

The Pension Plan assumes mortality risk by guaranteeing that benefits will continue for the life of each retired worker and surviving spouse. Workers don't have to worry about "out-living" their Plan benefits.



Contributions are invested and benefits are paid under one group trust. Worker benefits aren't harmed if contributions aren't made on time, or if financial markets decline right before retirement.

Pension Plan benefits are eligible for use as non-taxable housing allowance for Ministers of the Gospel who have qualified housing expenses in retirement.

### **WELS SHEPHERD PLAN** Saving for your future

The **WELS Shepherd Plan** is a defined contribution plan that allows WELS called and lay workers to save and invest during their working years to provide an account balance that can be accessed during their retirement years.

Each worker determines the amount that he or she wishes to contribute to their account and how their account should be invested within the Plan. Sponsoring organizations also have the option to make employer contributions to their workers' Shepherd Plan accounts.

### Value of the WELS Shepherd Plan to WELS Ministry

The WELS Shepherd Plan is available to workers who wish to supplement the benefits provided by the Pension Plan and Social Security. Because the Shepherd Plan account for each worker is portable across all WELS sponsoring organizations, workers don't have to worry about transitioning to a new retirement savings plan upon acceptance of a new call.

### Advantages of the WELS Shepherd Plan

The Shepherd Plan provides numerous advantages for both workers and sponsoring organizations, including:

# A growing worldwide economy amidst volatile markets

Market uncertainties during the last three months of 2018 overshadowed the investment gains earned by the WELS Benefit Plan trusts earlier in the year.

### Year-in-review

In the U.S., 2018 began with a continuation of the positive equity market performance and low volatility exhibited throughout 2017. However, concerns regarding trade tensions between the U.S. and China and the potential for interest rates and inflation to rise faster than expected fueled increased volatility and the first negative calendar year performance for the S&P 500 index since 2008. The U.S. economic fundamentals remained generally strong at the end of 2018, with unemployment at its lowest level since 2001, wages increasing at the fastest pace since 2008, consumer confidence remaining high, and GDP growth at its highest level since 2014.

Non-U.S. markets faced significant headwinds in 2018, including concerns regarding the ongoing UK exit from the European Union, slowing GDP growth in China and volatile oil prices. Equity returns for U.S. investors have been further diminished due to appreciation of the dollar relative to many local currencies in 2018.

### **Overview of WELS Benefit Plans investment returns**

Macroeconomic concerns and a return to higher volatility levels resulted in losses for many investors in 2018, including for the WELS Benefit Plan trusts:

- The WELS VEBA Plan trust achieved a return of -3.0%.
- The WELS Pension Plan trust achieved a return of -5.1%.
- The WELS Shepherd Plan trust\* achieved a return of -8.7%.

Although the VEBA and Pension Plan trusts posted net investment losses in 2018, contributions received from calling bodies have kept each Plan in a solid financial position to pay current benefit obligations. Shepherd Plan participants were not dismayed by the volatile markets, with annual contributions to the Plan achieving a record high \$10 million in 2018.

### A look ahead

The consensus among many economists is that the economic growth rate in the U.S. and globally will slow in 2019. The return to more normalized levels of volatility seen in 2018 is expected to continue and will remain sensitive to geopolitical events and interest rate actions taken by the U.S. Federal Reserve.

As prudent fiduciaries of the assets entrusted in their care, the Commissions endeavor to maintain broadly diversified portfolios with moderate return expectations. Optimization of the return, risk and cost profiles of each trust's holdings is a continued focus of the Commissions and is expected to preserve Plan assets available for benefits.

By pooling our Godgiven talents and resources with other congregations we can take advantage of lower cost, institutional priced investment opportunities that are not available to smaller investment accounts. As more congregations and organizations invest in WELS Investment Funds, the cost reduction benefits also increase. It's a way we can help support each other.
- WELS Investment Funds is easy to use. Executive Director Jim Holm, CFP®, an employee of WELS, is available to meet with your organization, either in person or via phone, to discuss the various investment options available through WELS. ### WHO CAN INVEST IN WELS FUNDS?

### HOW ARE THE FUNDS MANAGED?

WELS Investment Funds' Board of Directors has retained Vanguard Institutional Advisory Services® as the investment consultant for WELS Investment Funds. As a co-fiduciary, the investment consultant is responsible for making investment recommendations to the board. Once the recommendation is approved by the board, the investment consultant, after consideration of the WELS Investment Funds' investment policy statement and the various investment objectives and restrictions therein, has the discretion to implement and oversee the investment recommendations.

### MANAGEMENT

The Board of Directors of WELS Investment Funds is responsible for the operation of WELS Investment Funds, including the engagement of investment consultants. Directors serve four-year terms and are appointed by the WELS Synodical Council.

The day-to-day affairs are carried out by its officers and other WELS employees. For administrative convenience, efficiency, and cost effectiveness, WELS Investment Funds leases its personnel from WELS. WELS also provides services relating to the processing of transactions, preparing investor account statements, and the preparation of corporate financial statements.

### The Funds

New this year is the **WELS Endowment Fund**. It seeks to maximize the long-term growth of principal and is designed primarily for endowment funds. The WELS Endowment Fund is comprised of 75 percent equity and 25 percent fixed income and has a long-range investment time horizon.

The **WELS Balanced Fund** seeks to reduce potential volatility by including fixed income securities. It is comprised of 60 percent equity and 40 percent fixed income and has a mid- to long-range investment time horizon.

The **WELS Equity Fund** seeks long-term capital growth by investing in a portfolio of equity securities that is well diversified by industry and company size. WELS Equity Fund is comprised of 100 percent equities and has a long-range investment time horizon.

The **WELS Income Fund** seeks to provide income by investing primarily in investment quality debt securities. It is comprised of 100 percent fixed income securities and has a short- to mid-range investment time horizon.

The WELS Endowment Fund and WELS Balanced Fund invest in differing ratios of the same underlying mutual funds as the WELS Equity Fund and WELS Income Fund. The WELS Equity Fund and WELS Income Fund are for those ministries who desire an asset allocation other than the WELS Endowment Fund and WELS Balanced Fund.

### **EXPENSES**

All direct expenses and any expenses allocated by WELS related to the operation of WELS Investment Funds (e.g. rent for office space, utilities, financial, technological, and human resources expenses) are charged directly to the WELS Funds. While these expenses vary from year to year, for the fiscal year 2018, they were 0.21% of the assets in the WELS Funds.

All mutual funds that comprise the WELS Funds have investment expenses significantly below the industry average. The weighted average expense ratios for the WELS Endowment Fund, WELS Balanced Fund, WELS Equity Fund, and WELS Income Fund are 0.15%, 0.14%, 0.19%, and 0.06%, respectively.

The WELS Endowment Fund seeks to maximize the long-term growth of principal and is designed primarily for endowment funds. It is comprised of 75 percent equity and 25 percent fixed income and has a long-range investment time horizon.

All investments made pursuant to the custodial agreement will be held in the name of WELS Investment Funds (or such other entity selected by WELS Investment Funds) as nominee for the organization, with actual ownership of the investments remaining in the organization. Each organization investing in the WELS Funds will be assigned an interest (an "Ownership Interest") in the assets of each chosen WELS Fund reflecting the pro rata interest of the organization in the assets of the particular WELS Fund. The value of the organization's Ownership Interest may fluctuate as the value of the particular WELS Fund fluctuates.

# Giving support

### CONSULTING SERVICES

WELS Foundation provides planned giving support to WELS members through WELS Christian giving counselors who are specifically trained in both the spiritual and financial aspects of planned giving. The WELS Christian giving counselors coordinate planned giving efforts with other WELS advancement representatives, congregational planned giving committees, and directly with donors and their advisors. Find your local Christian giving counselor at wels.net/christiangivingcounselor.

### EDUCATIONAL SEMINARS

WELS Foundation hosts monthly educational webinars. The monthly webinars include timely presentations on various planned giving topics such as Charitable Remainder Trust Essentials, Achieving Donor Goals with Gift Annuities, Working with Donors and Their Advisors, and Making the Right Choice between a Gift Annuity and a Charitable Remainder Trust.

The educational webinars are made available by WELS Foundation at no cost to WELS Christian giving counselors, advancement and development officers, and congregational planned giving committee leaders.

### IRA CHARITABLE DISTRIBUTIONS

An IRA charitable distribution allows a donor who is 70.5 or older to give up to \$100,000 directly to WELS charities from an individual retirement account (IRA). The amount distributed will be excluded from income for federal income tax purposes. This may be an especially useful gifting strategy for those who do not itemize their income tax deductions. The IRA charitable distribution must go directly to a qualified charity. You can choose to direct the distribution to WELS Foundation, which in turn will distribute the money to one or more WELS ministries you designate and provide you with the proper acknowledgement. Interested donors will want to contact their WELS Christian giving counselor to find out more.

# A gift that pays income for life

### CHARITABLE GIFT ANNUITIES

A charitable gift annuity (CGA) is a contract between a WELS member and WELS Foundation in which the member makes a gift of cash or securities in exchange for fixed annuity payments, generally for life. After the Lord calls him or her home, the remainder of the gift is distributed to the congregation or ministry as designated.

Income payments from a charitable gift annuity may begin immediately, be deferred to a specific date in the future, or be deferred until an unspecified date in the future.

The donor receives an immediate income tax charitable deduction, and in most instances a portion of the gift annuity payments will be a tax-free return of the original principal. Examples of benefits of a \$10,000 charitable gift annuity:

# A tax-wise way of providing for children and church

### CHARITABLE REMAINDER TRUSTS

A charitable remainder trust (CRT) is created when donors transfer cash, securities (stocks, bonds, mutual funds), or real estate into a charitable trust but keep a specified income interest—usually for their life or for a period of years for their children. When the trust ends per the donor's designations, the property in the trust passes to their designated charitable beneficiaries, such as their church and/or synod. As of June 30, 2018, WELS Foundation administered 162 charitable remainder trusts.

# A gift that creates a lasting legacy

### DONOR ADVISED FUNDS

A donor advised fund (DAF) is a charitable giving vehicle wherein an individual, family, or corporation makes an irrevocable, tax-deductible contribution of cash, securities, or other property to WELS Foundation and at any time thereafter can recommend grant distributions to qualified WELS ministries. The fund can be established with current gifts, deferred gifts (such as charitable gift annuities and charitable remainder trusts), and testamentary gifts (such as wills, revocable trusts, or beneficiary designations for life insurance policies or retirement accounts).

The WELS Foundation donor advised fund program provides an alternative to the private family foundation. WELS members can accomplish many of the same goals but with far less administrative work and expense. With recent tax reforms that increase the standard deduction for many, some are using their donor advised fund to "bunch" gifts. This is where, if you do not have enough deductible expenses to exceed the standard deduction, deductions from multiple years are grouped to itemize in some years.

Even though the **Central Africa Medical Mission** began as an outreach tool for our first WELS missionaries in northern Rhodesia, the necessity and impact of our medical clinics are just as great in 2019 as in 1961.



Our clinics continue to touch the lives of thousands each month who would receive little to no healthcare otherwise. Our mission statement is "Christ-centered Healthcare Supporting Gospel Ministry". The Lord places hundreds of individuals at our doors each day; these are individuals in need of spiritual and physical healing. What a golden opportunity!

Exciting? Oh yes. Did you know a staff of 10-13 nationally trained medical professionals climb in our Toyota Landcruiser ambulance 4 days a week, along with supplies and medications, to travel to outlying villages? The Lutheran Mobile Clinic is unique in our method of delivering healthcare. Despite recent heavy rains and dangerous road conditions, our staff arrives each day ready to provide services with dignity, respect, and Christian love. One of our clinics has been chosen to be part of the Malawi health pilot for the malaria vaccination program administered to children under 2. The program requires 4 doses of medication and preventive education for the families.

In Zambia, the Lutheran Mission Rural Health Centre prepares to expand to the new building. An increase patient load requires more staff and more space. A nationally trained Clinic Administrator has been hired to assist Jackson Kalekwa, Chief Clinical Officer, with duties that Missionary Dan Sargent and Lutheran Mission Zambia performed prior. The new Administrator is a LCCA member, as is Jackson and 3 additional new hires. This will provide a solid Lutheran management at the clinic for the future.

While the clinics continue to expand services, the Lord has opened the hearts of many to support the work of the Central Africa Medical Mission. You see ... we operate solely on donations. Approximately \$300,000 employs 2 ex-pats, 30 nationals, their benefits and also purchases the needed supplies such as fuel and medications. We are reminded how the Lord stretched out the blessings of the loaves and fishes. Our Lord's work is never done and we are thankful to be a small piece of his mission work in Zambia and Malawi.

# FOREWARNED IS FOREARMED

As we observe the profusion of moral decline and perversity around us, one might be inclined to say, "Nothing surprises me anymore!" Don't be so sure.

As students of Scripture, we know that as time passes, there is a growing abundance of wickedness and a corresponding lovelessness (Matthew 24:12). It should not surprise us, therefore, to see the moral decline and perversity. What can surprise us, however, are the forms of immorality we see society quickly accepting.

The secular response is to fight the slide into immorality with political elections, tight legislation, and conservative judicial rulings. For the good of others, we favor such efforts, but that is not where our hope lies (Psalm 146:3).

The primary objective of every Christian is to spread the Gospel message of salvation through Jesus Christ. We are to communicate God's eternal solution to sin and suffering. We are not to change the hearts of others. The Holy Spirit does that. We are the messengers. To do that we must meet people where they are at spiritually. Often that means they hold to or practice the immorality that offends us.

It is the work of Christian Life Resources to use the challenging life and family issues of our time, and the times to come, as bridges to establish a relationship and share the message of salvation through Christ. While the erosion of morality, the assaults on traditional marriage, and the villainizing of contrary voices will be formidable challenges for the generations to come, they also provide opportunities for informed Christians to engage others with conversations about eternity, sin, and salvation.
## **ABORTION**

The polarizing nature of the abortion issue is evident as states like New York stake claim to the most liberal abortion laws in the nation, while others like Alabama pass the most conservative laws. The surge in state legislative activity is legal posturing in anticipation of the U.S. Supreme Court revisiting its infamous 1973 Roe v. Wade ruling which legalized abortion throughout the pregnancy in all 50 states and U.S. territories. The Court seems poised to overturn Roe v. Wade, which will revert abortion to a state-rights issue. As such, the battle to protect the lives of unborn children will focus perennially on state elections, legislation, and referendums.

#### The Exception Clause

Some people worry that the typical "exception clause" in opposition to abortion "except to save the mother's life" is obsolete. Although a mother's life pitted against her unborn child's life remains a small percentage of all pregnancies (at less than 1%), it is a possible dilemma. The "exception clause," however, admittedly fails to express the real intent.

The Wisconsin Evangelical Lutheran Synod, in its 2011 abortion resolution, better expressed that intent when it stated,

...in those extremely rare circumstances in which a pregnancy directly endangers the physical life of the mother, or the mother's condition directly endangers the life of her unborn child, we call for action towards preserving both lives however possible or preserving at least one life when preserving both lives is not possible;

## INFANTICIDE

Within a decade of legalized abortion, some American hospitals passively practiced infanticide by permitting disabled newborn children to die through neglect – under the guise of unwantedness. Killing unwanted disabled children is legal in the Netherlands under the infamous Groningen Protocol. Parents, in consultation with their doctor, can weigh the quality of a disabled newborn child's life. If the child's disabilities are determined to be severe, parents may authorize the doctor to terminate their child's life.

The infanticide debate is again raging in the United States. As states debate new abortion laws, the question arises, "What if a child, intended for abortion, is born alive?" Politicians supporting abortion rights are often hesitant to favor legislation requiring care for the newborn. While none have come out expressly endorsing the termination of the life of a newborn intended for abortion, the double-speak raises serious concerns.

## **GENE-EDITED BABIES**

The development of CRISPR technology has raised the possibility of editing the foundational genetic code of human beings. Specifically, no one knows how changing the DNA today to eradicate a potential health malady, will affect future generations who inherit the altered genetic code. There is a concern that rogue scientists are experimenting outside of peer review and ethics oversight. A Chinese doctor, He Jiankui, announced in late 2018 of his use of CRISPR to edit the DNA of developing twins to enhance their resistance to HIV. Southern University of Science and Technology in Shenzhen, in China's Guandong province, fired Jiankui for this action, but many people fear such rogue research continues with no ethical oversight.

## **BIRTH CONTROL**

There remains substantial confusion about the nature of acceptable birth control use. The matter involves both motive and method. It has been the position of CLR that with the proper motive, birth control of some sort may be considered. The method of birth control, however, becomes an important issue. Combination hormonal birth control remains classified as a Group 1 carcinogen by the World Health Organization. The FDA continues to claim hormonal birth control operates with a third mechanism that is abortifacient.

## TRANSPLANTS

The success of organ transplantation has created an organ shortage. In an effort to meet this challenge, researchers continue to experiment with stem cells (typically, adult stem cells) to grow replacement organs, 3D manufacturing to construct replacement organs, and xenotransplantation to take organs from certain animal species.

Some people fear that by agreeing to release their organs upon death for transplantation into others, doctors will take the organs before they are dead. Hypothetically that is a possibility, but legally it remains a criminal offense.

## **END-OF-LIFE CONCERNS**

CLR continues to offer state-customized versions of its Christian Medical Directive Statement as a free download on our website.

The national office continues to receive inquiries about the appropriateness and circumstance in authorizing a Do Not Resuscitate (DNR) order. We also regularly answer questions about levels of treatment for terminal conditions.

Lately, we have also received questions about the appropriateness of cremation, natural burial, and body donation for science.

## **GENDER ISSUES**

The sudden and pervasive embrace of gender-choosing, despite biological realities, has caught many unprepared. People who identify as "transgender" are those who identify with a gender other than theirs at birth. Those who identify as "transgender" who suffer related emotional distress are said to suffer from "gender dysphoria."

The reality of these issues is undeniable. We see it in our schools and congregations. At one time, professional counselors worked with those identified as transgender to bring their identity in line with their biological reality. Today, in states like California, such counsel is forbidden. Instead, society's emphasis is that those identifying as transgender are to be counseled to accept their new identity despite their biological reality. In many cases, these people pursue gender-switching surgery combined with hormone treatments.

It is becoming increasingly common for congregational members to report relatives who identify as gay or transgender.

Some pastors report that they have had repentant gender-switched individuals wanting to return to active participation in the congregation yet are unable to undergo a reverse restorative surgery.

## **CLOSING COMMENTS**

Pastor Robert Fleischmann is returning full-time as the National Director of CLR on July 1, 2019. He split his time as the National Director of CLR and as a parish pastor at his congregation in Slinger, WI, following the unexpected death of its pastor and CLR board member, Pastor David Hein, in February 2014. Pastor Fleischmann will continue his schedule of preaching and presenting for CLR across the country but will focus a majority of his attention on more writing on the issues and preparing a succession plan.

We also acknowledge the unexpected passing of our board member, Mr. Art Naujock, this past April. Art was very involved with our Michigan Chapter and was a valued member of the CLR team. We mourn his passing yet we celebrate his gain in Christ.

## 2019 SEW Conference Report

Thank you, brothers, for your faithful partnership in the Gospel. A continuing joy of this ministry is the privilege of working side by side with you, sharing your struggles, and aiding you in the areas where we can provide help. As we look forward to another year together, it comes with some unexpected surprises.

#### WI Department of Corrections Changes

Our ministry has been informed by Wisconsin's Department of Corrections that parish pastors who want to visit their own members who are incarcerated will be classified as "volunteers." As such, pastors will need to meet the following requirements:

- 1. They will need to fill out paperwork, including emergency contact information, at each institution where they want to visit members who are incarcerated.
- 2. They will need to go through "Volunteer Orientation" once each calendar year. That orientation, which will be offered at various institutions on dates set by the institution, will be valid for the entire system, and not just the institution at which the orientation was held.
- 3. They will need to be finger printed once every five years. Opportunities to be finger printed will be at locations and on dates which will be chosen by the Department of Corrections or a particular prison. Appointments will need to be made to be finger printed.

If a pastor fails to meet one or more of these requirements, then his request to schedule a "pastoral visit" with a member could be put "on hold" until all requirements have been met.

#### **Incarceration Follow-Up**

We want you to understand how to best serve your incarcerated member or friend.

- Make us aware that the individual exists in the system. We will do everything we can to follow his/her movement.
- We want to begin serving the individual as soon as he/she arrives at the local jail. Please notify us immediately, and inform us if you know of prisoner movement, whether it's about to happen or has already happened.

- After sentencing, the person generally is moved from county jail to state prison. At that point, a number is assigned, and provided that we have been notified that the person is in the system, we can track progress.
- At this point, "fraternization" rules apply to the IM chaplain. He is supervised by and responsible to the WI state chaplain. He cannot call, write a letter to, send an email, or in any other way correspond with or engage in a personal relationship with the prisoner or the family. This is where the role of the Executive Director comes into play. A letter is written, signed by the Ex. Dir, and sent from the IM office, informing the prisoner that we are aware of the transfer, and informing him/her of the ways we can serve. Every time that the prisoner is moved in the coming weeks and years, we will send another letter, informing the individual of the options available to him/her at the new facility.

#### Road Building, Reporting and Reimbursement

Thank you to every pastor and lay person who acts as a modern-day John the Baptist, building a highway--our God's work in hearts. A new reporting sheet has been prepared again this year. It has been expanded to be an all-in-one tool.

- to report the prisoners either under your care or no longer at the institution(s) you serve;
- provide stats for our ministry; and
- to apply for reimbursement. Without your feedback, we are unaware of prisoner movement, and lose opportunity to continue serving the individual.

#### Your Role is Vital

The most troubling day of my tenure at IM was the day I learned about a funeral at one of our churches. The man was a prisoner who had died in prison, after decades behind bars. I learned about him because of the church funeral. No family members and no pastors had informed IM of the man's presence in prison. As time went on, I assume pastors assumed that previous pastors had done that. The majority of the prisoner's time was spent in prisons visited weekly by Pastor Charlie Iles. Yet we were unaware of him. In all those years, we never served him with the Gospel. Please don't assume we know. Make sure.

#### First Responder Support

#### A reflection from Erik Zabell, Wisconsin Lutheran Seminary Junior on his work at Kingdom Prep Lutheran High School:

He has one of the strongest faiths I've witnessed of those in his class, and he has only believed for two years! I meet with him every week and he always talks about how much he loves coming to Bible study and reading about his Savior.
